

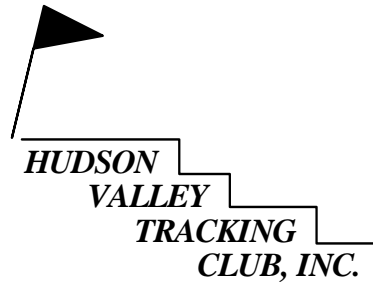

Bitches in Season – Bitches in season will be allowed to participate in accordance with Chapter 2, Section 8 of the AKC Tracking Regulations. Please note that the Test Secretary must be notified that a bitch is in season prior to the drawing for tracks. Bitches in season will be allowed to participate in a test only after all the other dogs and bitches not in season have been tested.

Drawing for Entries – A drawing for entries will be conducted in accordance with Chapter 1, Section 12 of the AKC Tracking Regulations, and will be held at the Test Secretary's home on Thursday October 16, 2008. The drawing will be at random except that preference shall be given to those dogs that have not earned a VST. There will be an alternate list with positions assigned according to the order in which they were drawn. Observers are welcome. The Test Secretary will notify all entries of the results by mail or e-mail.

Withdrawals and Entry Fee Refunds – If an entry withdraws between the closing date and the test date, and is replaced by an alternate, the entry fee will be refunded. Withdrawals must be made in writing to the Test Secretary. The entry fee for an alternate that does not participate will be refunded. Refunds will be returned to those who do not participate within one week of the Test.

Directions – Take exit NY State Thruway Exit 24 onto I90 East to Exit 3 which will bring you onto the outer loop road of the campus.. Take the first left turn onto the inner loop road and the next right into the parking lot.
